#### **CALL TO ORDER:**

Due notice of the meeting having been given and a quorum being present, the meeting was called to order at 5:35 PM by Mrs. Smith. The managing agent assisted in recording the meeting minutes.

The Pledge of Allegiance was recited.

#### OWNER FORUM

The following items were discussed:

- Concerns with Kempton Park nuisance
- Concerns with potential rainfall to come with Hurricane Harvey
- Owners thanked Sgt. Strain and his Deputies for the wonderful work that they do.

## **CONTRACT DEPUTY REPORT-SGT. STRAIN**

Lt. Cohen reported on behalf of Sgt. Strain:

Mrs. Smith reported that she is continually working with Jackie Kern on the Neighborhood Watch Program.

# Web-site Update- Tom Dougherty:

Mr. Dougherty is currently working with Web Administrator for FirstService Residential and Andrew Marquadat on the web-site upgrade options and plans to have report to present Board at next meeting.

#### Community Liaison/Social Committee:

Mrs. Smith reported on behalf of Mrs. Black that the details for the National Night Out event are being worked out. Mrs. Khan will request volunteers from the Honor Society to assist with handing out food and setting up for the event.

#### **MANAGEMENT REPORT:**

#### Financial Statement Review-July 2017:

Management reviewed the financial statements for the period ended July 31, 2017. On that date, the Association had a cash balance of \$458,306 in the operating fund and \$151,102 in the replacement fund. For the months ended July 31, 2017, the Association had total revenue of \$308,826 and total expenses of \$276,267 operating at a surplus of \$32,559. The report was accepted.

# **Deed Restriction Enforcement:**

Management reported that the association had 158 open violations.

## **SCHEDULING OF NEXT MEETING:**

The next meeting of the Board of Directors of Champion Forest Fund, Inc. was scheduled for September 27, 2017 at 5:30 PM and owners would be notified.

## **ADJOURN TO EXECUTIVE SESSION**

The Board adjourned to executive session to discuss legal matters and owner account requests.

#### **RECONVENE IN OPEN SESSION**
