#### CALL TO ORDER:

Due notice of the meeting having been given and a quorum being present, the meeting was called to order at 6:00 PM by Mrs. Matthews. The Managing Agent assisted in recording the meeting minutes.

#### Contract Deputy Report - Sqt. David Mathieu

Sgt. Mathieu gave a brief report of the constables work in the previous month

- Three runaways all involving the same child
- There were 116 contract checks, and 39 tickets issued
- Flock data successfully alerted local law enforcement to the locations of two stolen vehicles

#### Cypress Forest Pud Report – *Greg Dicioccio*

Mr. DiCioccio gave a brief report

- There is a special meeting on July 28<sup>th</sup> at 3 pm to discuss the potential development of apartments to the west, across the gully from the Estates at Windrush. The development would also abut the end of Chasemore Drive in Champion Forest. The developer is requesting "out of district service" from the CFPUD
- Potential proposed hydrology study of PUD land
- The PUD Park is suffering from the drought, emergency measures are being considered
- Regular monthly PUD meeting is Tuesday, August 2 at 5 pm
- Voluntary water conservation is requested of residents

# <u>Grounds and Maintenance Report – Mary Matthews on behalf of Amy Fontana</u>

- Mrs. Matthews advised that the approved water meter installations by EDP at Kimstone and Redchurch entrances are underway
- Irrigation crew workers are extremely busy, with the drought conditions causing damage to lines, so our two new irrigation installations are delayed
- Esplanade 21 irrigation has been added to the list of repairs due to major leak
- Summer color plantings have been completed

# Architectural Control Committee – Macie Steed, Ron Blum and Tom Dougherty

- Mrs. Steed reported that there were 16 ACC applications since the last meeting
- Twelve have been approved
- One is in progress
- Three have been denied
- Bon Hill lot is being monitored for development

## Wall Committee – Mary Matthews

- Section 7 the removal of two power pole brick wall surrounds that CenterPoint needed removed was approved through email vote and the work is being completed by Masonry Solutions
- Section 10 a new buyer on Landau is removing two trees that are close to the Community wall within their lot
- The recently approved relocation of the new light pole on Herts has been completed by CenterPoint

- Monarch submitted a writeup on Lawn Care in Drought Conditions, this has been posted via TownSq and the website to assist our homeowners
- Special July 28<sup>th</sup> PUD meeting has been posted on the signboards and website

## Financial Statements Review Ending June 30, 2022

• The operating account balance at the end of April was \$841,315.99 and the reserve account balance was \$438,619.00. Delinquencies outstanding total \$113,713.03 (Includes debtors accrued legal fees.)

# **Deed Restriction Enforcement:**

- During the month of July, there were 80 violations noted
- Violations included, but not limited to exterior maintenance and repair, exterior cleaning of the home, maintaining yards, pools, fences, unpermitted vehicles, and unpermitted signage
- Violations for lawns and power washing have been placed on hold due to drought
