Contract Deputy Report - Sgt. David Mathieu

- There were 182 contract checks made
- 66 traffic tickets were issued

- Champion Industries has ordered new recycling bins for all owners, but they are hoping to purchase the ones from Texas Pride that residents already have and sticker them
- New trash service guidelines will be circulated shortly

Grounds and Maintenance Report – Monarch, Amy Fontana

- Recent flooding has not caused too much landscape damage, the ruts on esplanades caused by vehicles seeking higher ground can be filled and rolled and irrigation will be assessed for damage.
 Board requested repair proposals for rut repair
- Stornoway irrigation repair is in progress and responsible owner will be billed as agreed
- Further freeze damage cutbacks will begin on February 6th or 14th

Architectural Control Committee – Liaison, Ron Blum

- 14 ACC approval applications have been submitted since the last meeting
- 10 have been approved, two are pending, two were denied

- Flock is being used to identify vehicles and had success identifying a vehicle in December
- The County Commissioner Tom Ramsey has ordered 300 Flock cameras for Commissioners Precinct 3 roadways

MANAGEMENT REPORT:

Financial Statements Review Ending November 30, 2022

- The operating account balance at the end of November was \$781,725.49 and the reserve account balance was \$456,559.68. Delinquencies outstanding total \$192,718.48
- Vote on ACC hearing for property account 471-3649, modification was approved with a vote of three for and one against approval

Banking:

• The Board approved two new accounts to be opened with Alliance which are 12-month jumbo CD's bearing 4.25% interest, with deposits of \$250,000 in each

Deed Restriction Enforcement:

- Violations included, but not limited to exterior maintenance and repair, exterior cleaning of the home, maintaining yards, pools, fences, unpermitted vehicles, and unpermitted signage
